STUDENTS COME FROM FIVE SOUTHERN CALIFORNIA COUNTIES, OVER 150 ZIP CODES, AND MORE THAN 80% LIVE IN LOW-INCOME NEIGHBORHOODS WHERE SCHOOLS PROVIDE LITTLE ACCESS TO ART AND DROPOUT RATES ARE HIGH.
